### Preliminary Report of

### the 2009 Construction Industry Survey: Southern Region

The National Statistical Office (NSO) carried out the 2009 Construction Industry Survey, which is the 3<sup>rd</sup> survey and the NSO planed for conducting this survey every 5 years. The main objective of the survey is to collect basic information data construction on establishment. Data is vital to economic development planning of the country and to private employment planning as well, the survey covered all construction establishment in the Whole Kingdom, which engaged in construction industry (Categories F of the International Standard Industrial Classical of All Economic Activities, ISIC: Rev.4). There are totally 3 division i.e. construction of buildings, civil engineering and specialized construction activities.


The field work was conducted during June 1 to September 30, 2009. The data presented in this report was the operation of the construction establishments located in **Southern region** during January 1 to December 31, 2008. The major findings are as follows:

#### 1. Number of establishments

The results of the 2009 Construction Industry Survey of 4,716 establishments in the Southern region, it was found that most of them (about 66.4 percent) were engaged in *construction* of buildings. Followed by those engaged in

building completion and finishing of about 11.2 percent. The establishments engaged in electrical installation and site preparation were about 8.4 and 7.8 percent respectively. The other class of construction industry not mentioned above had rather low proportion, each had less than 5.0 percent of the total.

# 2. Size of establishment (number of persons engaged)

Most of them were about 70.8 percent of establishments with 1-5 persons. The establishment with 6-10 persons was about 17.5 percent. For the establishment with more than 10 persons was 11.7 percent.

Considering by class of construction industry, it was found that most establishment (more than 60.0 percent) was small size with 1 – 5 persons. Except for those engaged in *construction* of roads and railways, construction of other civil engineering projects and other construction installation.



### 3. Form of legal organization

Most of construction establishments (about 88.4 percent) were individual proprietor. The establishments, which were in the form of juristic partnership was about 7.8 percent. Establishment, which were company limited and public company limited was about 3.8 percent.


Figure 2 Percentage of construction establishments by form of organization



### 4. Maximum capability

The majority of construction establishments in Southern region (about 76.3) had less than 1 million baht of maximum capability. For the establishments with 50 million baht or more of maximum capability had the least proportion of about 1.4 percent.


Figure 3 Percentage of construction establishments by maximum capability



### 5. Construct for government

The construction establishment in the Southern region, about 16.6 percent, constructed for government. Out of these, about 43.9 percent of establishments did the construction business with the government 50% or more. There were about 22.2 and 13.8 percent of establishments did the construction business with governments between 20 – 29% and less than 10% respectively.


Figure 4 Percentage of construction establishments by construct of governments.



### 6. Construction status

For the construction status of the establishments, which more than one characteristic can be done by an establishment, it was found that most establishments (about 71.6 percent) had *subcontractor only labour*. The following was *main contractor* of about 31.1 percent. For the establishment with *subcontracting parts to other* and *subcontractor* were about 9.6 and 4.7 respectively.

Figure 5 Percentage of construction establishments by construction status



# 7. Number of persons engaged and employees

In 2008, the workers of the construction establishments in the Southern region were totally 34,692 persons. In term of employment, the number of employees totalled to 29,510 persons. Considering by class of construction industry, it was found that most of them worked in *construction of buildings*, of about 24,378 persons or 71.0 percent. Followed by those worked in *construction roads and railways* about 3,144 persons or 10.7 percent. The rest engaged in construction industry not mentioned above.



### 8. Remuneration

In 2008, the employees working in construction establishment in the Southern region received the total remuneration about 2,068.9 million baht or about 70,109 baht per persons annually. The employees engaged in construction of roads and railways received the highest annual remuneration of about 79,328 baht per person. Followed by those engaged in other specialized construction activities and

construction of building receive the annual remuneration, of about 71,507 and 70,229 baht per persons respectively.

Figure 7 Remuneration of construction establishments by class of construction industry




## 9. Value of gross output, intermediate consumption and value added

The value of gross output or receipts of construction establishment was totally 19,043.8 million baht. The intermediate consumption and value added were totally 12,711.4 million baht and 6,332.4 million baht respectively. Comparing the value added to value of gross output or receive was about 33.3 percent.

For the average value of gross output had about 4.0 million baht per establishment and 548,957 baht per persons. In terms of the average value added, they were about 1.3 million baht per establishment and 182,538 baht per persons respectively.

Considering by class of construction industry, it was found that most of value added, was from *construction of buildings* with the highest proportion (about 57.9 percent). The following was from *construction of roads and railways*, (about 21.6 percent). The other class of construction industry had rather low proportion less than 6.0 percent.

### 10. Data comparison of construction establishments

Comparing the data of construction industry in 2009 and 2004 of which the operation period was of the year in 2008 and 2003, it was found that construction establishments increased by 59.4 percent, as well as number of persons engaged increased by 32.1 percent. However, average number of persons engaged per establishment decreased from 9 person to 8 persons or decreased by 15.7 percent.

In terms of employment, number of employees increased by 29.4 percent. It is noticeable that the average number of employees per establishment decreased from 8 persons to 6 persons per establishment or decreased by 18.2 percent due to lacking in labour.

The value of gross output, intermediated consumption and value added of construction establishment increased by 49.6 percent, 59.5 percent and 32.9 percent respectively.

### 11. Data summary and recommendation

The results of the 2009 construction industry survey, show that most establishments were small scale with 1 – 10 persons, of about 88.2 percent. The highlight industry was *construction of building* which had the highest proportion, of about 66.4 percent. For persons engaged in the establishments, there was totally 34,692 persons. Out of these, about 29,510 persons were employees. They received the annual remuneration, of about 70,109 baht per person. Moreover, the construction establishments of Southern region contributed value of gross output or receipts, intermediate consumption and value added, of about 19,043.8 million baht, 12,711.4 million baht and 6,332.4 million baht respectively.

The survey also incorporated questions concerning the business performance to prospect for the years 2008. The establishments about 48.9 percent reported that their performance decrease from the year 2007.

For government measurement needed; the establishment reported that reducing operation cost such as materials, equipment etc. and reducing corruption were about 59.8 and 26.3 percent respectively.
